A. Instructions to Bidders

1. Bids are to be submitted in person to the Head Office address as mentioned above.
2. Bids submitted online will not be considered.
3. Bidders are instructed to read and understand the eligibility criteria and terms and conditions.
4. EMD of the unsuccessful bidders will be returned/refunded after opening the financial bid and after finalizing the tender the EMD of the successful bidder will be refunded after successful installation and testing.
5. Bidders are advised to submit the tender strictly based on the terms and conditions and specifications contained in the Tender Document. Conditional bids will be summarily rejected.

B. Eligibility of the bidders:

1. Tenderer must be Original Equipment's Manufacturer (OEM).
2. OEM's / Exclusive Dealer of a branded company only to quote with authorization from the manufacturer.
3. Bids can be submitted by original equipment manufacturers or representatives of original equipment manufacturers or authorized dealers of as specified in Annexure I.
4. The firm should be registered with the GST and other required statutory registrations authorities.
5. List of clients to whom supplies were made with highlighting organizations along with contact numbers and work order copies to be furnished.
6. The over all dimensions tolerance of plus or minus 5% may be permitted in the item dimensions, except compromising the thickness.
7. The Company should have executed same business with a single order worth Rs.50 to 60 lakhs during the last 3 years.
8. Purchase Order copies of the third Party reference for the prove product supplies.

C. Each Bidder shall upload scanned copy of the following original / self-attested documents

Packet I:

1. Duly filled in Annexures I, Annexure II and Firm registration certificate.
2. GST registration certificate and PAN Card
3. Certificate of OEM / Representative of OEM / Authorized Dealer
4. Work orders/purchase orders from reputed organizations to meet the eligibility requirements.

Packet II: Annexure II – Financial Bid

Terms and conditions

1. Bids can be submitted directly from Original Equipment Manufacturer (OEM) or Representatives of OEM or authorized dealer .
2. Incomplete bids will be summarily rejected.
3. The supplier must ensure that all the specifications being offered in the quotation will be met by the equipment supplied. **The supplier must submit a table indicating the compliance of the features of the quoted model with those given in Annexure - I.** If any feature is not matching, it should be justified.
4. Minimum of **three-year warranty** is required on the main equipment and accessories from the date of installation.
5. Spare parts if any should be supplied with the instrument.
6. Utility and installation requirements (Electrical power, cooling water, compressed air, etc.) should be clearly mentioned in quotation.
7. Price quoted should be inclusive of all taxes, handing, transportation up to Campus, located in Belagavi District, installation charges, and training charges, if any .
8. Documentary evidences of system performance should be provided along with the submitted technical bid.
9. Quotation validity should be at least for 120 days.
10. Time required for delivery after issue of the purchase order or LC whichever is later order, should be provided.
11. The School Management reserves the right to postpone and/or extend the date of receipt or to withdraw the tender notice or not to place the order or to place order for part or full quantities without assigning any reason thereof at any stage of the tender. In such an event, bidders shall not be entitled to any compensation, in any form whatsoever.
12. Period of delivery of the items as per the tender specifications is 8 weeks from the date of Purchase Order (P.O).
13. Any legal action taken or proceeding initiated on any of the terms of the agreement shall be only in Belagavi jurisdiction.
